## **Project Based Voucher Wait List Opening Thorncreek Senior Living**

The Housing Authority of Cook County (HACC) will be opening a site-based wait list for one bedroom project-based voucher (PBV) units at Thorncreek Senior Living, a new construction senior housing community serving people 62 years of age and older, located at 400 East Margaret Street, Thornton IL 60476. This site-based wait list will be used to fill the PBV units only. The PBV Program is a rental assistance program where the resident pays 30% of his/her income towards the rent and the HACC subsidizes the remainder of the rent to the owner.

To be eligible for Thorncreek Senior Living PBV units, applicants **MUST** be 62 years of age or older and have income that does not exceed 50% of the Area Median Income (AMI), which is \$26,600 for a single person household and \$30,400 for a two person household. Preference will be given to applicants who are currently on the HACC's wait list. Occupancy at Thorncreek Senior Living is scheduled for January of 2016. It is anticipated the demand for the units will far exceed the units available.

Completed applications will be accepted on **Wednesday, September 16, 2015** from **10:00am – 3:00pm** at the Thornton Village Hall only, located at 115 East Margaret Street, Thornton IL 60476. Applications submitted before 10:00am will be rejected. If we do not receive 125 applications by 3:00pm on September 16, 2015, we will continue accepting applications by **mail only** until we receive 125. After 3:00pm on September 16, 2015, completed applications may be mailed to the following address only:
