We have also moved quickly to respond to the immediate needs the pandemic has placed on our households, providing essentials from masks and hand sanitizer to broadband Internet and laptops.

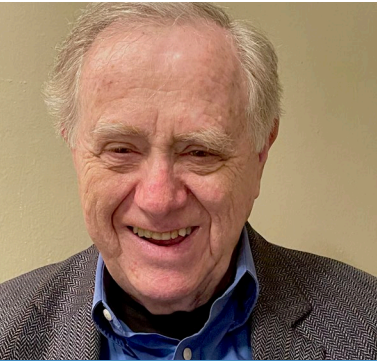

Dr. Normah Salleh-Barone

Dr. Normah Salleh-Barone joined the HACC board in July 2020. Dr. Salleh-Barone's experience in higher education administration goes back over 30 years. She has served as the Vice President of Student Development at Moraine Valley Community College since 2010. In this position, she leads the development, implementation, and assessment of initiatives, programs, and services in the Student Development departments; oversees the disbursement of \$25.5 million in financial aid funds; and supervises a \$9 million Student Development budget. Under her leadership, Moraine Valley has expanded its study abroad opportunities, created the Coordinator of Democracy Commitment position, and constructed a \$35 million, 113,000 square foot Fitness and Recreation Center, among other projects and innovations. Before her time at Moraine Valley, Dr. Salleh-Barone served as Assistant Vice President of Academic and Student Affairs at McHenry County College. Dr. Salleh-Barone holds a PhD in Educational Administration and a Master of Education from The State University of New York at Buffalo, as well as a Bachelor of Science in Education in English Literature from Ohio University.

She was selected for recommendation to Cook County Board President Preckwinkle by fellow residents. Commissioner Kroll has been a resident of Summit Senior Housing for over 8 years, and brings the much-needed perspective of HACC residents to the Board. A mother of three and a lifelong Chicagoan, Commissioner Kroll has significant experience in the insurance field, having worked at Continental Casualty Co. and General Accident Insurance Co. for many years.

Responding to COVID-19


Emergency Rental and Mortgage Assistance

As part of the Cook County Recovery Initiative, Cook County Board President Preckwinkle announced a \$20 million emergency rental assistance program on August 7th and a \$20 million emergency mortgage assistance program on October 8th. Both programs use CARES Act funding to provide relief to Cook County renters and homeowners who have experienced financial troubles due to the COVID-19 pandemic and who have fallen behind on their rent or mortgage payments. Both programs were operated by the team at HACC, using our existing infrastructure for processing payments.

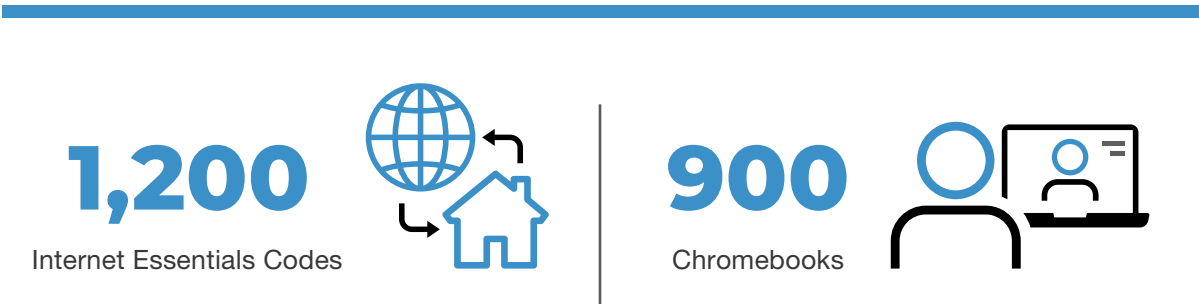

Keeping HACC Kids Connected to School

In the time of social distancing and virtual schooling, the digital divide threatens the ability of all children to learn and excel at school. HACC is dedicated to bridging that divide, and has committed over \$450,000 in CARES Act money to this purpose. HACC entered into an agreement with Comcast in August to cover the cost broadband access for families with children in school for the entire 2020-21 school year. So far over 1200 families have been granted unique codes in order to sign up for the program. The Human Services team also followed up with participants to determine whether or not each of their children had access to an e-learning device. To fill that need, HACC distributed 900 Chromebooks to K-12 students. These Chromebooks are a permanent gift to families, ensuring that students and their families continue to have access to the economic, educational, and social opportunities that home computers offer.





Improving Access to Healthy Food

Food insecurity is another major crisis of the COVID-19 pandemic. In spring 2020 and again in autumn, HACC and Top Box Foods teamed up to provide door-to-door deliveries of over 3200 boxes of meat and fresh, high-quality produce to families in HACC-owned properties, as well as protective personal equipment (PPE) including face masks and hand sanitizer.



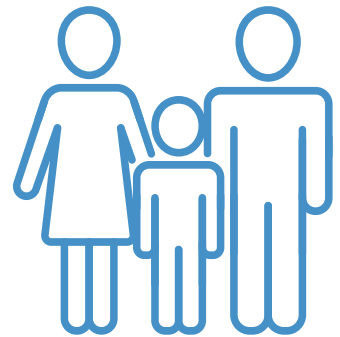
Expanding Access To Affordable Housing

HCV Waitlist Reopening

The HCV team opened HACC's Housing Choice Voucher wait list for the first time in over 18 years. Access to affordable housing is more crucial now than ever, and the need for housing assistance in Cook County is pressing and widespread. Over 60,000 families applied during the two-week application window for 10,000 available spots. The HCV Department expects to begin processing families from the new wait list in late spring or early summer 2021, and expects to process all 10,000 families over approximately four years. For these families, a Housing Choice Voucher is a lifeline to housing stability and the economy opportunity, and we look forward to serving these new applicants.

Project-Based Vouchers

Forest Oaks Senior Living, located in Forest Park, will host 56 units, offering one- and two-bedroom residences to seniors aged 55 and older. Forest Oaks apartments include in-unit washers and dryers, stainless steel appliances, and private balconies, among other amenities.

Developers broke ground on the **Fifth Avenue Apartments** in Maywood in January 2020. The mixed-use property will host 72 units of affordable housing in studio, one-, two-, and three-bedroom configurations, as well as 4,000 square feet of retail space on the ground floor. The building is designed to achieve National Green Building Standard's Bronze Level and receive ComEd's Energy Efficiency Grant for affordable housing.

Kenzie Senior Residences at Randhurst will provide 74 units of affordable housing with supportive services to seniors 55 and older in Mount Prospect. Construction on the property began in September 2020. When complete, Kenzie Senior Residences will offer its residents community spaces and lounges.



New Affordable Housing for Veterans

In 2021, ground will be broken on a new 82-unit rental housing complex for veterans, in Chicago Heights. The development will be built on the site of the recently demolished St. James Hospital. The Illinois Housing Development Authority, through federal Low-Income Housing Tax Credits and other sources, provided the majority of the funding. Cook County and the Federal Home Loan Bank also contributed resources.

Veterans who have experienced homelessness and insecure housing can apply to live in this beautiful new complex, comprised of adjoining 4-story structures. Supportive service providers will offer a wide menu of services to residents, including mental health and substance abuse counseling, and job training and placement, to enhance their quality of life and help them become self-sufficient.



A Spectrum of Services for Residents

Family Self-Sufficiency

The goal of the Family Self-Sufficiency (FSS) Program is to assist participants with improving their education and job skills for the purpose of becoming gainfully employed. FSS Program participants are required to establish goals such as completing educational training, resolving personal issues that are hindering their advancement, and actively working towards reaching their goals. Dedicated FSS

Counselors work with residents to set and work toward educational and financial goals. FSS participants who increase their earnings have the corresponding amount of increased rent set aside in an interest-bearing escrow fund, which they will receive upon completion of the program. **298 families** are currently participating in the program. In 2020, 12 participants graduated from the FSS program.

Some of their success stories:

Lisa C – Lisa completed the program and received an escrow check of \$18K. Her main goal was to pursue a career and have stable employment. She is now a nurse working at Advocate Aurora South Suburban.

Diane F – Diane's main goals were to save money and purchase her first home. Her dream came true in March 2020 when she closed on her new home. Diane continues to work as an Instructor for Roosevelt University on a part-time basis.

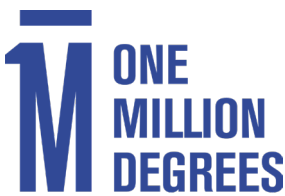
Mariesha C – Mariesha completed the FSS Program and earned a total of about 15K in escrow. Mariesha's main goal was to continue working as a daycare provider. She will be using her escrow funds to open her own daycare facility and be her own boss.

Community Choice Program

HACC's Community Choice Program provides Housing Choice Voucher recipients with the help they need to find their dream homes in high-opportunity communities in Cook County. Areas of Opportunity are identified by HACC as high-performing suburban communities that contain low poverty rates, low unemployment rates, high-performing schools and racial diversity. Residents who enroll in the program complete a series of workshops providing information on finding and securing a rental unit in these areas. Topics covered in workshops include financial literacy, tenants' rights and housing search tips. Dedicated Mobility Counselors connect residents interested in moving to Opportunity Areas with local landlords, help them arrange transportation to tour units, and assist with security deposits. In 2020 the Mobility team successfully helped 58 families to relocate to Opportunity Areas.



beWELL is a comprehensive, web-based tool designed to connect residents to community resources and opportunities throughout suburban Cook County. The website provides easy, online access to educational, occupational and supportive resources available for residents and their families across Chicagoland.

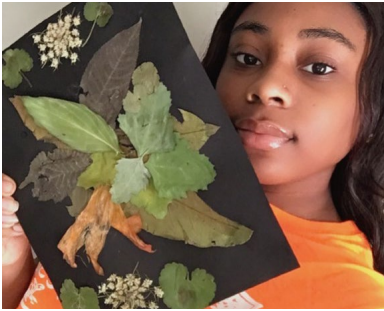
2020 marked the fifth year of the HACC Scholars Program with One Million Degrees. One Million Degrees provides counseling, financial assistance, and supportive services to low-income students at Prairie State and South Suburban Community Colleges. During the 2020-21 academic year, HACC funded individualized counseling and support for 27 HACC resident scholars.



HACC hosted four young men from Youth Guidance's Becoming A Man (BAM) program for paid summer internships at the downtown and South Suburban offices. Participants shadowed the Director of Construction to learn more about trades; assisted with file preparation and IT updates; and performed direct service by distributing back-to-school packs to children with Cradles to Crayons.

Forest Preserves Experience

The Forest Preserve Experience is a five-week program that engages high school-age HACC youth in a paid opportunity for hands-on conservation work and education. This year, due to the COVID-19 pandemic, FPE moved from environmental restoration at the Forest Preserves of Cook County to virtual conservation education focused in the participants’ own neighborhoods. Even with this year’s challenges, the program was highly successful. A total of 96 HACC youth participated in environmental education sessions, job readiness workshops, independent projects, and team building activities throughout the summer.

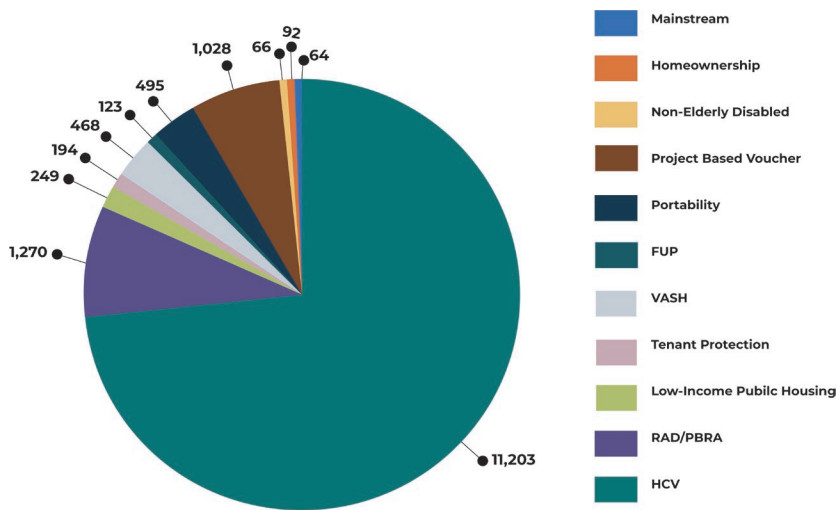

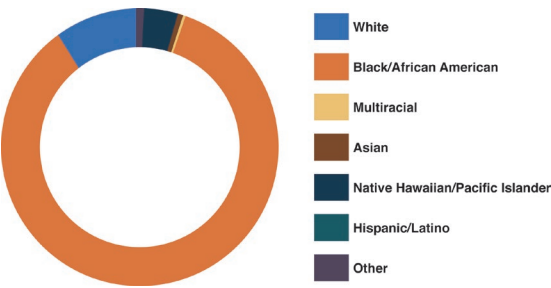
