
From the Desk of the Executive Director

It is my pleasure to provide you with our 2022 Annual Plan.

The need for affordable housing opportunities for low-, moderate-, and middle-income households has never been greater. And the changing winds of the real estate market, impacted negatively by high interest rates and increased construction costs, has further exacerbated this problem. In Cook County alone, an additional 200,000 homes and apartments are needed just to meet current demand. And when additional housing is not built at the scale necessary, except for those at the highest income levels, rents increase further.

And when you add the effects of high inflation, housing affordability is even more precarious.

This is why we remain committed to adding to the housing supply. We expect to break ground on two new





We are especially proud of having kept nearly 21,000 households in their homes and apartments by providing \$161 million through the Emergency Rental Assistance Program. This served as lifeline to those whose livelihoods were upended by the pandemic. As the report highlights, the Housing Authority touches many populations, including lower-income children and seniors, people with disabilities, those leaving the foster care system, and many more. The one thing that these groups have in common is, by and large, that their housing needs are not met by the private marketplace. Government assistance is a necessity. Still, only 1 in 4 Americans that need housing assistance actually receive it, due to a severe lack of resources.

There is no question that these are turbulent times for the housing market. This makes our mission even more challenging. But we remain steadfast in serving the needs of the 16,000 households we assist. And to the many more we will serve in the future.


Dr. Normah Salleh-Barone | Commissioner

Emergency Rental Assistance

The economic upheaval caused by COVID -19 impacted the entire country. But those most affected were low- and moderate-income households.

Two of the best programs that came out of the Cares Act and the American Rescue Plan assisted households in paying their mortgage and rent.

All told, HACC expended nearly \$12M to lenders and over \$150M to landlords to keep over 20,000 households safely housed. The program paid arrearages that mounted because people lost their jobs, got sick, or were required to take care of children or other loved ones.

"In all my time in government, this was one of the most impactful federal programs I have seen," said HACC Executive Director Richard Monocchio. "The stress created by the pandemic demanded an overwhelming federal response to keep people housed. We were proud to implement this program, and especially heartened by the fact that Cook County was able to get money to people quicker than any other jurisdiction in the country."

On average people whose livelihood was upended by the pandemic received \$8,150 in rent or mortgage assistance.

A Spectrum of Services for Residents

Women's Resource Expo

The Housing Authority of Cook County, in collaboration with many other community stakeholders, hosted our first-ever women's resource expo. This event is a one-stop shop for homeless women or women facing homelessness, women who have been victimized by domestic abuse, and women who previously were incarcerated. We took a proactive stance to remove the barriers that prevent these women from leading productive lives. This event occurred on October 5, 2022, at White (Willye B.) Park, located at 1610 W Howard St, Chicago, IL 60626.

The women's resource expo provided many resources to our constituents and other marginalized groups. The resources were inclusive of the following: counseling, transportation, food, clothing, shelter, child support services, primary health care referrals, screening for blood pressure, vision, veterans' information, employment services, education/training services, and a variety of other social service agencies. Numerous faith-based organizations were present as well. There were 62 vendors present, and we were able to assist over 350 individuals throughout the day. Special thanks to Executive Director Richard Monocchio for his vision and leadership regarding bringing this event to Cook County.

Holiday Giveaways

This holiday season, HACC worked with Cradles to Crayons to distribute an awesome variety of items to residents at Vera Yates Homes, Sunrise/Bergen Apartments, and Richard Flowers Community Housing. At our first annual Holiday Giveaway, HACC distributed: 1,500 books, 350 school supply packs, 500 clothing outfit packs, 400 winter accessory sets, 300 baby & adult hygiene kits, and 625 winter coats.







Forest Preserve Experience

The Forest Preserve Experience is a five-week program that engages HACC high school-age youth and young adults in a paid opportunity for hands-on conservation work and education. In 2022, its sixth year, HACC continued to work with Friends of the Forest Preserves to provide over 100 teens and young adults with summer employment opportunities—Their largest cohort yet!

Participants had the opportunity to earn money while learning about conservation, clearing harmful undergrowth from our Forest Preserves, and participating in team-building activities. This year, FPE crews visited Moraine Valley Community College to learn more about their future career and educational opportunities, traveled to the Indiana Dunes, canoed the Des Plaines River, and so much more. HACC is proud to support such a unique and meaningful program that benefits so many of our residents.









After School at Richard Flowers

Fun at Flowers, HACC's signature After School program, is now in its second year at Richard Flowers Community Housing. The program provides homework help, enrichment activities, and a healthy snack for about 18 students in grades 1-8 living at RFCH. Our Youth Coordinators work together to identify and address individual needs, provide social and academic support, serve as trusted mentors to the kids, and put together fun holiday events and special activities. Some of our favorites for this school year include our Pajama Day, visits to William Leonard Public Library, time spent at the Robbins Community Center, and Halloween pumpkin painting. We are excited to continue working with our Richard Flowers families and the Robbins community to serve our youth.





Summer Camps

For the second summer in a row, HACC was able to work in tandem with local Park Districts and other community organizations across the County to provide summer camp opportunities for over 100 school-age youth (ages 6-14). The Housing Authority was also pleased to work with Adults Active in Youth Development for the second time to send over 30 youth to their renowned STEM Camp, held at the Dixmoor Community Center. About 70 Summer Fun Scholarships were awarded to youth attending Hazel Crest, Streamwood, Robbins, Markham, or Lan-Oak Park Districts' summer camps. Each camp gave our youth the opportunity to make new friends, travel to new places, and experience things they haven't before, and we are looking forward to another great summer in 2023.

Opportunity Fund

Education is the key to economic mobility, and HACC is committed to supporting residents who are seeking their degrees/certificates at Cook County community colleges. Now in its second year, the Opportunity Fund is a barrier-reduction scholarship that aims to assist these residents with some of the costs associated with attending college. HACC residents who are currently enrolled in one of the County's eight suburban community colleges are eligible for up to \$500 per semester in assistance for transportation, childcare costs, and laptops. The Fund served about 50 students this year, most who are non-traditional.

Family Self-Sufficiency and Homeownership

The goal of the Family Self-Sufficiency (FSS) Program is to assist participants with improving their education and job skills for the purpose of becoming gainfully employed. FSS Program participants are required to establish goals such as completing educational training, resolving personal issues that are hindering their advancement, and actively working towards reaching their goals. Dedicated FSS Counselors work with residents to set and work toward educational and financial goals. FSS participants who increase their earnings have the corresponding amount of increased rent set aside in an interest-bearing escrow fund, which they will receive upon completion of the program. 172 families are currently participating in the program. In 2022, 32 participants graduated from the FSS program. FSS participants are also eligible for HACC's Homeownership Program, which allows households to use Housing Choice Vouchers to pay monthly mortgage costs. 8 families purchased homes this year.




