Dear Interested Pre-Applicant,

The Housing Authority of Cook County (HACC) Low Income Public Housing Program will re-open the wait lists for **one, two, three, and four bedroom** standard and accessible units located at 1314 Wentworth Ave, Chicago Heights, IL 60411 for persons 18 years of age and older. The household will be required to pay rent equal up to 30% of their adjusted annual income.

The annual income limits are as follows:

*1 person household: \$51,000; 2 person household: \$58,250; 3 person household: \$65,550;
4 person household: \$72,800; 5 person household \$78,650; 6 person household: \$84,450;
7 person household: \$90,300; 8 + person household: \$96,100*

****income limits are subject to change per HUD Guidelines***

Preferences will be given to the following:

Families with children; Veterans and veteran's widows/widowers;

Victims of Domestic Violence; Elderly families (head, spouse, co-head or sole member is 62 years of age or older); **Disabled families** (head, spouse, co-head or sole member is a person with disabilities); **Homeless families** (an individual or family, who lacks a fixed, regular and adequate nighttime residence and whose primary nighttime residence is a supervised publicly or privately operated shelter designed to provide temporary living accommodations; OR an institution that provides a temporary residence for individuals intended to be institutionalized; OR a public or private place not designed for, or ordinarily used as, a regular sleeping accommodation for human beings. Verification for this preference may include documentation provided by a homeless service organization (third party verification will be requested).

Applicants claiming a preference must be able to demonstrate they qualify for the preference. These preferences will apply to all units. Applicants will be selected from the waiting list based on the highest number of preference points and based on the date the application was received by the HACC. Preferences are cumulative. For applications with no preference indicated, the applicant will be placed on the waiting list according to the date the application was received by the HACC. Received applications are dated and will be ranked in order received by HACC's current computer software program.

No more than two (2) persons will be permitted to occupy a bedroom. Management will balance the need to avoid overcrowding with the objective of maximum utilization of space, as per the following occupancy standards:

Persons of the opposite sex (other than spouses, and children under age 5) will not be required to share a bedroom; Persons of different generations will not be required to share a bedroom; live-in aides will be allocated a separate bedroom (no additional bedrooms will be provided for the live-in aide's family); single person families will be allocated a one bedroom; and foster children will be included in determining unit size.

Pre-Applications will be available online beginning **Tuesday October 6, 2020 at 10:00 AM**. To apply, please log onto the HACC's website at www.thehacc.org and from HACC's homepage click on the link "See Our Open Waitlists." Under Low Income Public Housing Program, the applicant must select "Sunrise Apartments" and then select "Applicant/Resident login" to begin the online- application for housing. If you have applied online before for this specific property or if this is your first time applying to this property, you must select "**Click here to register**" and create a new email and password to register. Pre-applications will be available to be submitted electronically through the website; the wait list will close at **4:00 PM on Thursday October 8, 2020**.

HACC will only accept up to 150 applications per bedroom size in order to decrease wait time.
